## Universal Coin International, Inc., Web Site Privacy Policy

### YOUR PRIVACY MATTERS

Thank you for visiting [UCOINcurrency.io](http://UCOINcurrency.io), which is owned and operated by Universal Coin International, Inc., ("UCI").

**By using or accessing the Site in any way, you acknowledge that you accept the practices and policies outlined in this Privacy Policy, and you hereby consent to our collection, use and sharing of your information in the manner described herein.**

UCI is committed to respecting and protecting your privacy. Please read this Privacy Policy carefully in order to understand what information UCI collects about visitors to the Site, and how UCI uses that information. If you do not agree with the content of this Privacy Policy, please do not use this Site. We encourage you to check our Site frequently to see the current Privacy Policy and Terms and Conditions of Use in effect and any changes that may have been made to them. If we make material changes to this Privacy Policy we will notify you by posting the revised Privacy Policy and the revised effective date on this Site, by sending you an e-mail, and/or by some other means. Please note that if you've opted not to receive legal notice emails from us (or you haven't provided us with your email address), those legal notices will still govern your use of the Site, and you are still responsible for reading and understanding them. If you use the Site after any changes to the Privacy Policy have been posted, this means you agree to all of the changes. This Policy is part of our Web Site Disclaimer.

This Privacy Policy only covers our treatment of your personal information that we gather when you are accessing or using our Site, but not to the practices of companies we don't own or control, or people that we don't manage.

### TYPES OF INFORMATION COLLECTED BY UCI

UCI collects two types of information from visitors to the Site, non-personal information and personal information. Non-personal information is information that does not, by itself, identify the visitor as a specific individual. Personal information, is information that specifically identifies a visitor to the Site, or which includes contact information. If you sign up to receive UCI news, provide contact information or other information



about yourself when signing up for a UCI event, or express interest in the UCI Crypto projects, UCI may request and you may be required to provide personal information, including, without limitation, your e-mail address. By providing UCI with personal information via the Site, you expressly agree to its collection and use as described in this Privacy Policy. If you do not want to receive communications from us, please indicate your preference by clicking on the “Unsubscribe” link at the bottom of an email message.

## **COLLECTION OF INFORMATION**

Visitors may access the Site while remaining anonymous and without revealing any personal information. UCI may collect information during your visit to the Site through our automatic data collection tools, which may include cookies and other commonly used information-gathering tools. These tools collect certain standard information that your browser sends to our website such as your browser type and language, access times, and the address of the website from which you arrived at a UCI website. They may also collect information about your Internet Protocol (IP) address and clickstream behavior (i.e. the pages you view, the links you click, and other actions you take in connection with UCI websites).

A "cookie" is a small piece of data stored on a user's browser, and contains non-personally identifiable information about the user. When you visit the website, UCI may place a "cookie" in order to improve your experience by recognizing you when you visit the website and in order to allow the company to optimize the information presented based on your demonstrated areas of interest. Cookies may also be used to compile information about website usage. If you subsequently provide us with personal information such as your email address, we will associate any cookies on your browser with that information such that you will no longer be an anonymous visitor to the site.

Your browser may offer you a “Do Not Track” option, which allows you to signal to operators of websites and web applications and services (including behavioral advertising services) that you do not wish such operators to track certain of your online activities over time and across different websites. Our Site does not support Do Not Track requests at this time, which means that we collect information about your online activity both while you are on the Site and after you leave our Site.



## CHILDREN'S PRIVACY

UCI is committed to protecting the privacy of young children, and therefore does not knowingly collect or maintain personally identifiable information on the Site from persons under 13 years of age, and no part of our website is directed to persons under the age of 13. IF YOU ARE UNDER 13 YEARS OF AGE, THEN PLEASE DO NOT USE OR ACCESS THE SITE AT ANY TIME OR IN ANY MANNER. In the event that UCI discovers that personal information has been collected from a person under 13 years of age, without verified parental consent in accordance with the Children's Online Privacy Protection Act of 1998 ("COPPA"), UCI will delete such information.

## HOW UCI USES AND SHARES INFORMATION

UCI may use personal information you provide in order to contact you. For example, if you sign up for the UCI newsletter, UCI may use your contact information to send you the UCI newsletter and other communications from UCI. If you provide UCI with contact information or other information about yourself in connection with a UCI event, UCI may use that information internally and to communicate with you regarding UCI's events. Because UCI is committed to protecting your privacy, UCI will not sell, rent or otherwise disclose this information to any third party, except as described in this Privacy Policy. Personal information may be disclosed under the limited circumstances described below, and you agree that UCI may do so by submitting your personal information. By providing any personal information to the Site, all users, including without limitation users in the European Union, fully understand and unambiguously consent to the collection and processing of such information in the United States. UCI may share non-personal information from which individuals cannot be identified, and which do not relate to individuals in aggregate form, with third parties for business purposes, such as consultants and advisors to the company. UCI will disclose your personal information to a third party if required to do so by law or if, in good faith, UCI believes that such action is necessary to: (1) comply with the law or with legal process; (2) protect and defend UCI's rights and property or prevent fraud; (3) protect UCI against abuse, misuse or unauthorized use of UCI's products or services; or (4) protect the personal safety or property of its personnel, users of this Site or the public. The servers that serve the Site automatically identify a computer by its IP address. If UCI, in good faith, determines that you have used the service to menace, threaten, harass, intimidate or otherwise deceptively pose as another person, your actions will be



investigated and your IP address may be disclosed to the recipient of any email, their legal counsel or representatives, and law enforcement officials as part of such an investigation. UCI may transfer its database, including personal information contained therein, to a third party who acquires all or substantially all of the assets or stock of UCI whether by merger, acquisition, reorganization or otherwise.

If you submit unsolicited business plan ideas or slide decks to UCI through the Site, UCI cannot and will not accept responsibility for protecting against misuse or disclosure of any confidential or proprietary information included in such materials, in the absence of UCI's express written agreement to do so. Except as expressly set forth in this Privacy Policy with respect to your personal information, any plans, information and other materials you submit in connection with this Site may be used or disclosed by UCI for any purpose and in any manner, as UCI determines in its sole discretion. Please consider this carefully before sending UCI any information or other materials that you deem confidential or proprietary.

## **INFORMATION SUBMITTED BY CURRENT OR PROSPECTIVE UCI FELLOWS**

If you submit information about yourself, such as your name, contact information, resumé, and other transactional materials, UCI may use such information internally in connection with its cryptocurrency projects. Additionally, UCI may share such information with its portfolio companies so that such companies may review your materials and contact you in connection with the cryptocurrency projects. Be aware that UCI does not control the portfolio companies' actions with respect to such information, and assumes no responsibility for how the portfolio companies use the information UCI provides to them in connection with the cryptocurrency projects. UCI will not share such information with any other third parties, except as specified in this Privacy Policy.

This Site (including, without limitation, such features as UCI's newsletters) may contain links or otherwise provide access to third party websites and services. Please be aware that UCI has no control over the policies and practices of third party websites or businesses as to privacy or anything else and is not responsible for the privacy practices of such other websites.
